NCGTC recognizes the expectations of its customers with regard to privacy, confidentiality and security of their personal information that resides with the organization.


Privacy Policy governs the way in which the organization collects, uses, discloses, stores, secures, and disposes of personal information and sensitive personal data or information residing within the organization

7. Information We Collect

We collect only the information needed for legitimate business purposes.

The personal information such as your full name, email ID, contact details, and other essential credit information etc. is captured when an individual or Member Lending Institution who needs to avail our services, sign-ups for an account, registers for an event, or asks for customer support. If services are availed ,we may collect the personal information such as full name, email id, contact details, address, designation, fax with other essential credit details from an individual or through Member Lending Institutions..

We may collect personal information directly from publicly available databases, social media sites or in collaboration with our partners from time to time. You may also need to provide some personal information if you wish to explore employment opportunities with us.



8. What we do with your personal information

We do not share or sell your personal information to anyone. We use personal information solely for the purpose of interacting with you and to validate various scheme parameters. We use personal information only for the specific reason for which it is provided.

Some personal information is required:

- To manage, administer and fulfil the obligations under contracts.
- We will only use your personal data for the purposes for which we collect it, we reasonably
 consider that we need to use it for another reason that is compatible with the original
 purpose and applicable local law. Any exceptions will be brought to your notice and the
 legal basis for the same will be explained.

9. We will not share your personal information

We do not share your personal data with anyone else and we will never sell personal data. However, exemptions to the above are where NCGTC is asked to provide information because of any legal or regulatory requirements. We will make every effort that such mandated disclosures from the regulatory authorities are communicated to you.

10. How long will we keep your personal information?

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements. In some circumstances, we may anonymize your personal data so that it can no longer be directly associated with you.

11. How will we keep your information safe?

We are fully committed to information security and compliance with applicable regulations. We have implemented strong security controls for the protection of data. We have designed and implemented an information security program that is being implemented /implemented in line with International Organization for Standardization (ISO) 27001:2022.

Though we take reasonable measures to protect our assets against unauthorized access or attack; the Internet inherently is not fully secure. While we work towards and strive to protect your personal information/privacy, we would like you to take note of the inherent Internet risks
